

## VIP Vacation Breckenridge Certificate Program

This program is designed to provide the Colorado skier/rider a deluxe mountain vacation worth much more than actual purchase price. These vacations are made possible by limiting reservation confirmations to 21 days of desired arrival date. These getaways are sold in "4 paks". Prices include all taxes and fees.

1. What your Certificate recipient gets:
  - a. A Certificate that is good for a two or three night stay in a deluxe condominium in Breckenridge, Colorado. Once issued, the certificate is good until 1/31/2008. The Breckenridge units are at Wedgewood Lodge, Ski Side and Ski Hill or another fine property, are either ski in/ski out or just steps from the lift.
  - b. The value of the offer varies and is based upon length of stay and season. Depending upon season the value of each certificate can be worth over \$600. Certificates will be good for a choice of the following:

2. Certificate Distribution and Activation: Purchaser or account contact can personally use or can assign an individual certificate to his/her designated recipient as desired.
  - a. Certificates are initially inactive for security purposes.
  - b. Certificates are initially listed in the name of the individual purchaser or account contact on behalf of a business account, if applicable. When the purchaser or account contact desires to either use or give away a certificate, the certificate must be activated or activated and transferred via email or fax. You will be provided with a form listing the required information that we will need to activate your certificate and you will be asked to write in the name of the gift recipient on the actual certificate. Confirmation of transfer or activation will be made within 3 business days after receipt.
  - c. A government issued ID will be required upon check-in and must match the name of the purchaser or transferee.
3. Terms:
  - a. *Validity-* Activated gift certificates are valid for use by the individual whose name is listed on the certificate from time of activation until expiration date listed. Purchaser can assign, transfer or activate certificates once at any time prior to expiration. Certificates are non-transferable after initial activation or transfer.
  - b. *No-risk policy:*  
*Refunds-* All accounts can return their full order of non-distributed/activated certificates for a full refund within 30 days of purchase for any reason. After that time, for 4-paks, accounts will receive a full refund less a \$30/certificate fee if all four certificates are returned. If one or more of the certificates have been used or distributed, a pro-rated refund will be provided after deducting for used/distributed certificates based upon the single certificate price of \$349 each.
  - c. *Satisfaction Guaranteed-* We guarantee your satisfaction. We will solve any problem to your satisfaction or will refund your money in accordance with item "4.b." above.
4. Reservations-
  - a. *Requests-* Please email ([res@vacationtravelsystems.com](mailto:res@vacationtravelsystems.com)) or fax (303-380-9042) the following information: your name, certificate number, complete mailing address, primary telephone number, alternate telephone number, fax (if any), email address, choice of arrival date (21 days or less before arrival) and number of nights desired based upon the above grid. Reservations are filled on a "first-come, first served" basis. Upgrades for larger units (up to 3 bedrooms) and extra nights may be available. If interested in an upgrade, please indicate this on your fax or email request. Last minute requests (5 days or less before arrival) will be considered with a \$30 expedite fee.
  - b. *Confirmations-* Your reservation will be confirmed via email or fax within 48 hours of your request. In the event your requested dates are unavailable, you may request an alternate date. Don't forget, alternate dates are subject to the 21-day rule. Once a reservation is confirmed, no changes or refunds are allowed. For upgrades or last minute reservations, you will be asked to mail a check or money order payable to Vacation Travel Systems, LLC, PO Box 3729, Englewood, CO 80155. Payments must be received within 3 business days of confirmation or reservations are subject to cancellation.
  - c. *Check-in-* Check-in information will be provided upon confirmation. Upon check-in, please present your certificate for payment, along with a valid government issued ID and credit card for your security deposit. It is helpful to have a copy of your confirmation with you.
  - d. *Cancellations-* Upon confirmation, all reservations are final.
  - e. *Holidays and peak travel periods-* Although there are no official black-out dates, space during holidays and peak periods is extremely limited. Please plan your request accordingly to avoid disappointment.
5. Other terms and information-
  - a. *Activation-* This certificate is only valid after activation by the purchaser.
  - b. *Non-transferable-* This certificate is void if sold or bartered and is non-transferable after initial activation or transfer.
  - c. *Occupancy:* The number of guests may not exceed 4 persons per studio/one bedroom, 6 persons per 1 bedroom/loft or 2 bedroom, and 8 persons per 2 bedroom/loft or 3 bedroom.
  - d. *Responsible Adult-* This certificate may only be used by a responsible adult (25 years or older with valid ID). A responsible adult must accompany any minor at all times on the property.
  - e. *Security deposit and other important information—*i) a security deposit via credit card will be collected upon check-in and will be refunded upon checkout. Occupants will be responsible for excessive cleaning, any unit damages or long distance calls. ii) There is a no-smoking and no-pet policy for all properties. iii) Check-in time is 4:00 PM, check-out time is 10:00 AM. iv) Parking is limited and available for one vehicle only. v) This certificate is valid until January 31, 2008. vi) Rules and hotel policies are subject to change. vii) We reserve the right to substitute similar quality accommodations as required. viii) In case of emergency or for further information call VTS at 800-447-2373.
